Fertile plain of Zeta, composition of the River Zeta and Ribnica with Morača, immediate vicinity of Skadar Lake and

Adriatic Sea, favourable climate, communication and strategic position, made it possible Podgorica to become the biggest urban agglomeration of Montenegro. Large number of subterranean waters makes this area known by healthy drinking water. River Morača and River Ribnica have a special value and a natural beauty and they cross the City North-South and East-West. It is not only a modern city, but the city which represents administrativ, political, economic, traffic, scientific and educational-cultural center of Montenegro. The Adriatic Sea makes an influence on the climate of Podgorica, along the vale of River Bojana, through the Lake of Scadar. Under the influence of surrounding mountains, Mediterranean climate is changing, so that Podgorica has Mediterranean – changed climate, which is characterized by warm and hot summers and mild and rainy winters.

“Porto Montenegro”— The Mediterranean’s leading luxury yacht homeport and marina village.

The genesis of this project came when Porto Montenegro's primary investors identified an extraordinary opportunity: an overwhelming demand for yacht berths around the Mediterranean. With this, they sought to create a world-class marina that would satisfy the growing shortage of berths, while allowing outside investors to share in the long-term capital appreciation that waterfront property and berths have enjoyed over the past 50 years.

Previously a historic naval base, the site's transformation into a luxury yacht marina has been led by some of the world’s most respected business figures including UK businessman Lord Jacob Rothschild, the founder of luxury conglomerate Louis Vuitton Moët Hennessey, Bernard Arnault, and Peter Munk, founder and former chairman of Barrick Gold.

In 2016 Porto Montenegro was acquired by the Investment Corporation of Dubai (ICD), the principal investment arm of the Government of Dubai with investments spanning financial services, transportation, energy and industries, real estate and leisure and retail.

“Plantaže” — Leading Montenegrin Wine and Brandy Manufacturer:

We believe that the wines are ‘the children of the terroir’ and that the character and quality of wines originate directly from the vineyard and that is why we have been committed to the production of wines which can completely express their origin. Thus, everything that we do in the vineyards and in the cellars, we do with great respect to our own country, to our own vineyard and grapes, grown in it. Following the greatest world standards in modern wine making, we apply the innovations, as well, following the latest scientific research in the fields of viticulture and wine making.....The wine cellar is located on the average depth of over 30m below the ground. Its shape is like a spiral tunnel, 356 m length, average width 13,5 m and 7m height. The temperature is almost permanent-between 17 and 19 degrees. Humidity -70-80%.
