Global Entrepreneurship Monitor is funded by the Research Council of Lithuania and has been carried out since 2011. The IBS at VU researchers group has recently prepared the Annual Lithuanian Entrepreneurship Monitor 2013 report. It is the third report. The result of the report has been distributed via the daily newspaper - Business News and local conferences. Every year, the report is widely presented to both - the business community, and the general public. Research data was collected by using the Global Entrepreneurship Monitor (GEM) methodology. Since 2011, IBS at VU researchers group is a member of the Global Entrepreneurship Research Association.

The paper showcases the contextual development of age diversity in Lithuania and explores the theoretical grounding and empirical evidence of the role of work characteristics (work-scheduling autonomy, decision-making autonomy and social support) in the age—individual performance linkage.

NEW SCHOOL OF LAW - STRATEGIC GOAL FOR ALMU

One of the School's most important tasks is to train new-generation lawyers for the business sector including entrepreneurs, businessmen and large companies. This is the first School of Law in Kazakhstan with a special focus on business and on training lawyers and counsels to protect rights of businesses.

Assylbek Kozhakhmetov, President of Almaty Management University: «Unfortunately, there is a way to go for our legal culture to be fully developed. Larger companies have an opportunity to protect their interests but small and medium-sized businesses often see even their basic rights violated. However, entrepreneurial right is an independent and very important area of law and there are very few specialists with adequate expertise in this field. The school will specifically address this shortage and will train lawyers and counsel for business."
